Bulk Water Agreement

WHEREAS the Town has constructed a multimeter dispensing station for the purpose of dispensing POTABLE WATER to their customers, hereinafter called "Bulk Water Station", situated at the Town Pumphouse on SR 583, hereinafter called "the said lands", and whereas the Customer is desirous of purchasing potable water from the Town.

NOW THEREFORE both the Town and the Customer agree as follows:

- 1. The Customer agrees to pay a \$50.00 deposit to the Town. When the Customer terminates this agreement this deposit will be applied to any outstanding balances on the Customers account and any credit balance will be refunded back to the Customer.
- 2. The Customer agrees to responsible for any and pay all water sales recorded or registered on the Customer's Card Number. The Customer agrees that if their account is in arrears 60 days or more the Town has the right to deactivate the Customer's Card Number until payment arrangements have been made.

- 3. The Customer agrees that the minimum monthly consumption must exceed 5 m3. A charge of \$15.00 per month will be levied to cover the minimum consumption.
- 4. The Customer, and/or any employees and agents agree that use of the Bulk Water Station and entering onto the said lands is entirely at the Customer's own risk.
- 5. The Customer hereby agrees to indemnify and save harmless the Town from and against any and all loss, costs, expenses, damages, claims, actions and causes of action arising out of or resulting from the use by the Customer of Bulk Water Station, provided however, that this indemnity shall not apply to the extent that any such loss, costs, expense, damages, claims, actions or causes of action were contributed to by defective equipment forming part of the Bulk Water Station.
- 6. The Customer may terminate this agreement by notifying the Town by phone or by letter at:
