## General

The Town of Three Hills (the "Town") has prepared this Request for Quotation ("RFQ") to provide annual maintenance and servicing of rooftop Heating, Ventilation, and Air Conditioning (HVAC) units located at multiple Town facilities. This contract will include both Fall and Spring preventive maintenance as well as on-call service and repair throughout the year to ensure optimal performance and reliability of all equipment.

The HVAC systems covered under this RFQ are located at the following Town facilities (Details of Units in Schedule A):

- Three Hills Community Centre (212 Main Street)
- Three Hills Aquatic Centre (221 4 Avenue NE)
- Three Hills Town Office (232 Main Street)
- Three Hills Fire Hall (111 1 Avenue NE)
- Three Hills Arena (202 3 Avenue NE)
- Three Hills Library (135 2 Avenue SE)

The successful proponent will be responsible for providing all labour, materials, tools, and equipment necessary to perform scheduled maintenance and respond to service calls in a timely and professional manner. The Town is seeking qualified contractors with experience in municipal or commercial HVAC systems and the ability to deliver a comprehensive maintenance program.

# **Proponent Expenses**

Proponents shall bear their own costs associated with or incurred in the preparation and
presentation of its Quote, including, if applicable, costs incurred for meetings, interviews or
demonstrations related to this RFQ prior to the issuance of a contract.

#### **Multiple Quotes**

• If multiple Quotes are offered, the Proponent must submit each Quote separately in the same format as outlined in this RFQ. Quotes must meet the fundamental intent of this RFQ.

#### **Submission of Quotes**

- The Town will receive sealed Quotes until the RFQ Closing.
- Quotes are to be prepared in such a way as to provide a straightforward and concise description
  of capabilities to satisfy the requirements of this RFQ.
- Quotes must be submitted in the format described in *Schedule A Quote Requirements*.
- Quotes must be sealed and clearly marked with:
  - RFQ's name
  - RFQ Closing
  - and addressed to the attention of the RFQ Contact

• All quotes must include the following information to be considered:

#### Company Information

- Company name, address, and contact details
- Name and title of the authorized representative submitting the quote
- Summary of relevant experience, particularly in municipal or commercial HVAC maintenance

#### Pricing

- Annual cost for Fall and Spring preventive maintenance visits (broken down by visit, if applicable)
- o Hourly rate for on-call service and repairs outside of scheduled maintenance
- Pricing structure for parts and materials (e.g., cost-plus percentage or discounted rate)
- Any travel or additional fees that may apply

#### Scope of Services

- Confirmation of the ability to provide Fall and Spring maintenance as well as on-call service throughout the year
- List of typical tasks included in seasonal maintenance (e.g., filter replacement, inspection of belts, checking refrigerant levels, thermostat testing, etc.)
- Annual Report including but not limited to the following (overall conditions, key issues and recommendations, any equipment nearing end of life cycle, major repairs completed etc.)

#### Proposed Schedule

- Suggested timeline for seasonal maintenance visits
- o Response time for on-call and emergency service

#### • Warranties and Service Guarantees

o Details of any warranties or service guarantees for labour and parts

#### • References

 A minimum of three (3) references for similar commercial or municipal HVAC maintenance contracts

#### • Proof of Insurance & Safety Certifications

- o Certificate of liability insurance and confirmation of worker's compensation coverage
- Copies of relevant safety certifications or training credentials

### Offer and Acceptance of Quotes

 At any time prior to the RFQ Closing Date and Time, a Proponent may withdraw its Quote by submitting written notice to the RFQ Contact.

## **Evaluation Criteria**

Quotations will be evaluated based on the following criteria:

- Pricing (50%) Competitive and transparent pricing structure for maintenance and on-call services
- Experience & Qualifications (20%) Demonstrated experience with municipal or commercial HVAC maintenance, qualifications of personnel
- **Service Approach (15%)** Proposed maintenance schedule, response times, and overall service plan
- **References (10%)** Quality of references from similar contracts
- Insurance & Certifications (5%) Proof of appropriate insurance and safety credentials
